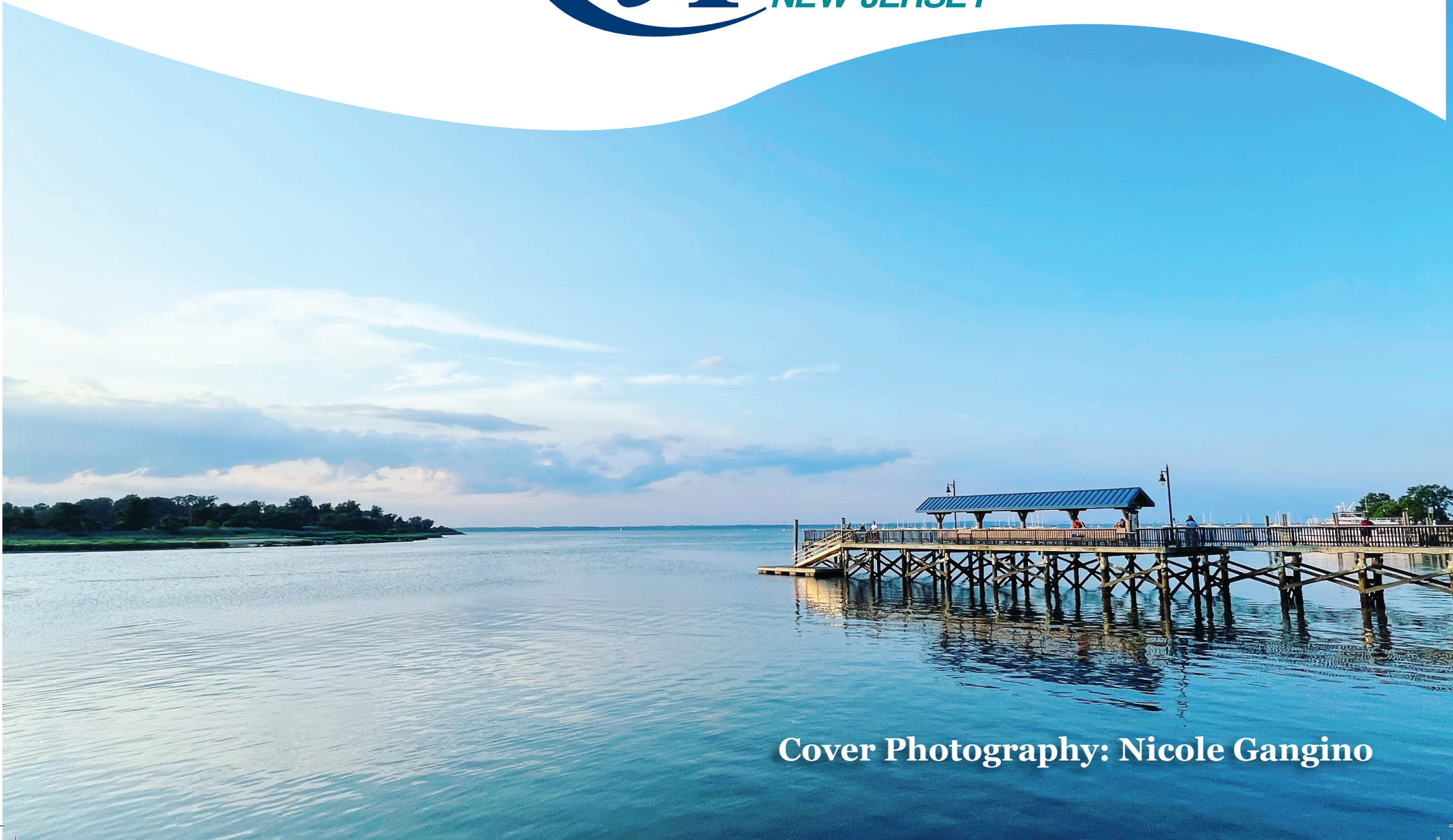

Keyport is situated on the Raritan Bay, along the Eastern Coast of New Jersey. It is approximately 25 miles southwest of New York City.

Keyport is known for its picturesque waterfront along the Raritan Bay. This area offers scenic views and recreational opportunities.

Keyport is accessible by several major roadways, including Route 35 and Route 36. The Garden State Parkway is also nearby, providing easy access to other parts of New Jersey.

HOUSEHOLD GARBAGE COLLECTION

The Borough of Keyport will provide garbage collection to any residential dwelling or business in the Borough that meet the following requirements:

- ⇒ Each single-family home is allowed up to 3 containers (with lids) that do not exceed 50 pounds and/or up to 50 gallons in capacity each per pick up. Multifamily homes as well as Mixed use buildings are allowed up to 6 containers. Businesses without residential addresses are allowed up to 4 containers. All materials must be in plastic bags before being placed into the containers which must be placed curbside the night before not prior to 4pm the scheduled pick up. (Ordinance 16-5.3 (1) and 16-5.4)

Items **NOT** Acceptable for Garbage Collection:

Brush, cans and bottles, mixed paper, newspaper, asphalt, cardboard, chipboard (cereal boxes, etc.), leaves, appliances, drums, tanks and tires, toilets, sinks, tubs, windows & doors.

RECYCLING COLLECTION

Recycling is unlimited regarding the number of cans but is still limited to the size and weight restrictions.

Bottles and plastic are to be placed in containers
Newspaper, Junk mail, office papers, books, magazines, cardboard/boxes should be tied in bundles or placed in a container

Containers must be placed curbside the night before scheduled pick up

ELECTRONIC & METAL RECYCLING– This includes: computers, monitors, fax machines, computer related electronic equipment, televisions, and phones.

ALSO, any metal items such as washer, dryer, stove, bicycle, fencing, bed frames and such. You will need to call 732-739-5136 to schedule a pick-up date before placing the items to the curb. The only items that would need a permit are air conditioning or refrigeration. You may purchase the permit from the Municipal Clerk’s office at Borough Hall.

RECYCLING DATES FOR 2025

All recycling will be collected on **EVERY OTHER WEDNESDAY** including: cardboard, newspaper, all types of paper (magazines, chipboard, junk mail, and mixed paper), bottles and cans (aluminum, steel, plastic #1 & #2, plastic - neck of the bottle should be smaller than the base).

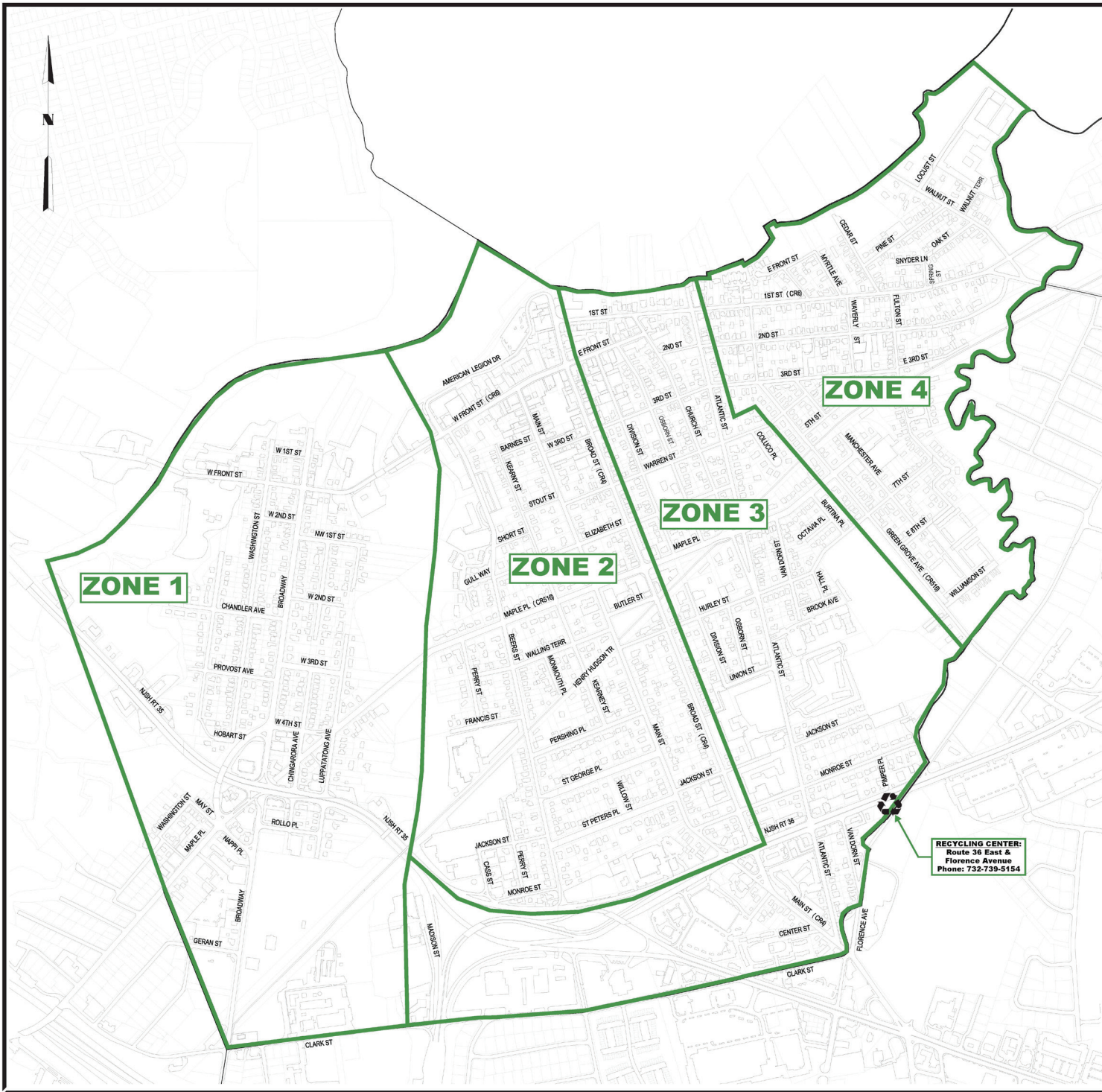

Place all solid waste curbside on scheduled day; exceptions are New Year's Day, Christmas Day and Thanksgiving Day; they will be picked up the following day

Borough Ordinance 16 5.3(1) requires trash containers NOT to exceed 50 gallons in size and 50 pounds when loaded. Container limitations for solid waste pick up are as follows: Single family 3 cans, Multi family 6 cans and Commercial properties 4 cans. Recycling is unlimited regarding the number of cans but is still limited to the size and weight restrictions. Borough Ordinance 16 5.4 indicates no person shall place any garbage, refuse, recyclables, bulk or other solid waste on the curb for collection from any residential, commercial or mixed use property prior to 4:00 p.m. the day before the scheduled pickup nor allow any empty containers to remain on the curb after 7:00 p.m. of the day of collection and all such containers shall be stored in a manner as to not create a nuisance to neighbors and the public.

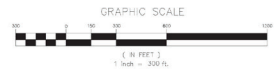

LEAVES AND BRANCHES

Leaf & Branch Pick up

Section 1 & 2 April 16, May 7, Sept. 17, October 15, Nov. 5, December 10
Section 3 & 4 April 23, May 14, Sept. 24, October 22, Nov. 12, December 17

Leaves and Branches will **ONLY** be collected during these periods of the year. Branches must be neatly stacked, tied and cut into length not exceeding 6 feet. You may bring leaves and branches to the recycling center on Saturdays when the recycling center is opened.

Do not mix sticks, tree branches, grass or other debris in with leaves. **Leaves in open containers or clear plastic bags will not be accepted.**

GRASS CLIPPINGS: Grass clippings have been banned from the County Landfill. The Borough of Keyport will not collect them.

Saturdays from 9am—12am

CHRISTMAS TREES may be placed to the curb on Wednesday's during the months of December, January, and February.

BULK PICKUP: You are allowed to put out one bulk item with each trash pickup. Rugs must be cut, rolled, and tied 6' lengths a limit of four rolls per pick up. The following are not included in bulk pick-up:

Brush, leaves, concrete, asphalt, scrap metal, white goods (appliances), paint, oil, antifreeze, all liquid substances, wood scraps, glass containers, aluminum cans, newspapers, cardboard, mixed paper, batteries, light iron, heavy iron, & tires.

Street Sweeping will be conducted town wide three times a year during certain weeks. Date and time are subject to change due to weather.

Question: What are the guidelines for placing contractor debris out for collection in Keyport Borough?

Answer: For contractor debris, no debris related to construction or renovation projects will be collected by the municipality. This includes but is not limited to brush, wood, concrete, dirt, and other construction materials. .

Question: What are the procedures for disposing of electronics, appliances, and scrap metal in Keyport Borough?

Answer: If you have items like appliances (e.g., washers, dryers, hot water heaters, stoves, dishwashers, dehumidifiers) or electronic devices (computers, monitors, televisions), you must call the Keyport Borough at 732-739-5136 to schedule a pick up. DO NOT place items to the curb without a scheduled pick up date.

Scrap metal must be neatly stacked and cut into lengths not exceeding 6 feet (or 50 pounds) for collection.

A \$20 sticker fee is required for items containing Freon, such as refrigerators and air conditioners, and doors must be removed from appliances before collection.


Propane and BBQ grill tanks should be taken to the Monmouth County Household Hazardous Waste Facility by contacting them at 732-683-8686. Latex paint cans can be dried and placed in the garbage, while other paint cans must follow specific disposal procedures.

Question: What are the reminders and precautions for residents when disposing of waste in Keyport Borough?

Answer: Residents are reminded not to put food waste, oils, or grease down their drains. Debris should not be placed within 10 feet of any catch basin or storm drain, and all materials must be separated into different piles that cannot be mixed together with anything else.

What are the benefits of reducing waste & recycling?

Keyport Borough Recycles

In the state of New Jersey, both residents and businesses are legally obligated to participate in recycling initiatives. The purpose of these requirements is to promote a sustainable environment, reduce waste production, and generate revenue for local communities. By adhering to these rules and actively participating in recycling efforts, residents and businesses can contribute to the overall wellbeing of their community and the environment.

Waste disposal is an expense borne by local taxpayers or through trash collection fees. Each ton of general trash costs approximately \$75 for communities to dispose of at landfills or incinerators. By reducing waste generation or recycling materials, you effectively lower the waste disposal costs for your community while enabling them to profit from the sale of recyclable materials to recycling companies. The more actively a community participates in recycling, the more income it can generate from recycled materials' collection and, consequently, the more funds it will have available to allocate towards essential services such as local schools.

Recycling is crucial for conserving valuable resources and energy. By recycling and reusing existing materials, we reduce the need to extract new raw materials, thereby preserving our planet's finite natural resources. Furthermore, recycling processes typically consume less energy than producing items from new materials, leading to lower greenhouse gas emissions and reduced environmental impact.

To ensure that your recyclables are collected and appropriately processed, it is essential to familiarize yourself with the latest recycling guidelines in your area. These rules may specify which items can be recycled and how they should be prepared for collection. Contaminated or incorrectly sorted recyclables risk being rejected by designated disposal markets, leading to potential non-collection from curbside locations.

To avoid such issues, it is vital to separate non-recyclable materials from your recyclables and refrain from using plastic bags for curbside collection. By adhering to these guidelines and actively participating in recycling efforts, you can make a positive contribution to your community's environmental sustainability and financial wellbeing.

For the most accurate and up-to-date information regarding recycling rules and guidelines, we recommend referring to the Keyport Borough website or checking the annual calendar provided by the town. To ensure that your recyclables are collected and processed effectively, adhere to the following list of acceptable items for each category:

1. **Glass & Plastic:** These materials can be mixed together in your recycling bin. Acceptable items include aluminum cans, glass bottles, plastic bottles, steel cans, and tin cans. The number of cans allowed is unlimited, but size and weight restrictions apply.
2. **Paper:** This category includes newspapers, junk mail, office papers, books, magazines, cardboard, and boxes. These items should be mixed with other recyclables in your designated recycling container.
3. **Miscellaneous Items:** For construction and demolition materials, residents must remove these at their own expense. If using a dumpster for this purpose, a permit from Borough Hall is required. Other miscellaneous items include tires, household hazardous waste (such as chemicals, paint, and batteries), propane tanks, gas cans, and fire extinguishers. Information on disposal options can be found on the County website (www.visitmonmouth.com).
4. **Textiles:** Clothing and fabric items can be placed at the curb on your regular trash day for collection.

Please note that recyclables should not be placed in plastic bags, as they will not be picked up if contained in this manner. The recycling center is open on Saturdays from 9 AM to 12 PM (except for holidays). By adhering to these guidelines and actively participating in recycling efforts, you can contribute positively to your community's environmental sustainability and financial wellbeing.

Tax and Water Sewer Utility Billing and Collection

Tax Bills are due in four quarterly payments on the following dates:

February 1st
May 1st
August 1st
November 1st

Water/Sewer Bills are due in four quarterly payments on the following dates:

January 1st
April 1st
July 1st
October 1st

Each quarterly payment has a ten-day grace period that includes the due date. Interest is calculated at 8% for balances up to \$1500.00 and 18% for delinquencies over \$1500.00. Please call the tax office if your payment is overdue, interest accrues daily.

You may make your payment in person, online, by mail, or in the 24-hour drop box in the vestibule of the municipal building. If you require a receipt when mailing your payments, please enclose your entire bill and enclose a self-addressed stamped envelope.

Application forms for all of the following deductions are available in the Tax Collector's or Tax Assessor's Office.

Senior Citizen Deduction

There is a Senior Citizen deduction of \$250.00 for property owners over sixty-five (65) years of age. Senior Citizens must provide proof of age. Your income may not exceed \$10,000, but Social Security, certain government pensions and Railroad Retirement are excluded from this figure. Income verification for the previous year is required annually.

Disabled Persons Deduction

There is a Disabled Persons deduction of \$250.00. Permanently Disabled Individuals must provide proof of disability. Income may not exceed \$10,000 a year, but Social Security, certain government pensions and Railroad Retirement are excluded from this figure. Income verification for the previous year is required annually.

Veteran Deduction

There is a Veterans or surviving spouse deduction of \$250.00. Veterans must be a legal resident of New Jersey and have owned the property as of October 1st of the pretax year. Veterans must be honorably discharged with active duty military service. A copy of your DD214 is required and a copy of your NJ State Driver's License.

Surviving spouses must be a resident of New Jersey and have not remarried, have proof that the deceased veteran was a resident of New Jersey at the time of death and own the property that the deduction is claimed for.

Municipal storm sewers carry water away from roads and houses to nearby rivers and lakes. It is important that we keep pollution out of the system.



Senior Center

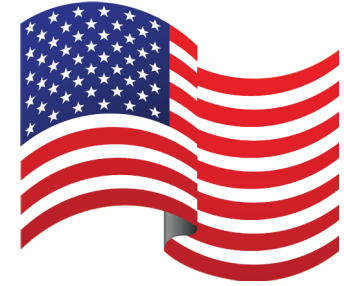

Application made for inspection, approval and issuance of a Change of Occupancy for the following dwelling/business units as provided by the Code of the Borough of Keyport 12-2.3.

NO PROPERTY MAY CHANGE OWNERSHIP OR OCCUPANT PRIOR TO THE ISSUANCE OF A CERTIFICATE OF INSPECTION

Applicants need to obtain a **CHANGE OF OCCUPANCY** for a residential or commercial property sale, rental, or transfer of title for occupancy.

MINIMUM 10 BUSINESS DAYS NOTICE REQUIRED FOR INSPECTIONS

- ⇒ The date and time must be approved by the Inspecting Official.
- ⇒ Please provide a phone number where you can be reached for the date & time confirmation by the Official.
- ⇒ A \$75.00 **NON-REFUNDABLE** fee must be paid at the time of application (made out to the Borough of Keyport).
- ⇒ Failure to make application for an inspection and obtain a Certificate of Occupancy for each new tenant or buyer of a business/dwelling is punishable by a fine in the amount not exceeding \$1250.00.
- ⇒ Smoke Detector Inspection Fee Minimum \$45.00.

Construction Department

Construction Official & Building Sub-Code Official

If you are planning an improvement to your property you must obtain the necessary building permits. Local ordinances must be adhered to before a permit can be processed through the Building Department. The Building Department uses state and national regulations as guidelines for actual construction/alteration work. All work must be Inspected to ensure that it is performed according to code.

NJ State Uniform Construction Code 5:23-2.14 states: It shall be unlawful to construct, enlarge, repair, renovate, alter, reconstruct or demolish a structure, or change the use of a building or structure, or portion thereof, or to install or alter any equipment for which provision is made or the installation of which is regulated by this chapter, or to undertake a project involving lead abatement in accordance with NJAC 5:17, without first filing an application with the Construction Official, or the appropriate Sub-code Official where the construction involves only one Sub-code, in writing and obtaining the required permit therefore.

Please check with the Building Department to see if permits are required. Some projects require a combination of permits.

The following is a partial list of improvements for which permits are required:

Building permits are required for most improvement projects including additions, alterations, renovations, demolition, asbestos removal, tank removal, decks, sheds, fireplaces, wood/coal burning stoves and chimneys, signs, above ground and in-ground swimming pools, pool fences, cabanas and gazebos.

NOTE: A building permit will not be issued until **ALL ZONING** or other prior approvals have been obtained.

- All properties and structures shall meet the most recent Property Maintenance Code.
- No house/apartment clean outs are allowed. A resident or home owner must remove at their own expense.

Property Maintenance

The Borough of Keyport has a new tree ordinance that has been implemented to enhance and protect the green spaces in our community. To comply with this ordinance, residents must follow specific procedures regarding any tree removal on their properties. Please check with Keyport's property maintenance for more details.

CONDITIONS CONSTITUTING A PUBLIC NUISANCE:

Conditions constituting a public nuisance include any of the following:

- A. Any physical condition or occupancy of any premises or its appurtenances considered an attractive nuisance to children, including but not limited to, abandoned wells, shafts, basements, excavations and unsafe fences or structures
- B. Any premises that has unsanitary sewerage or plumbing facilities;
- C. Any premises designated as unsafe for human habitation;
- D. Any premises that is manifestly capable of being a fire hazard, or is manifestly unsafe or unsecure so as to endanger life, limb or property;
- E. Any premises from which the plumbing, heating or facilities required by this code have been removed, or from which utilities have been disconnected, destroyed, removed or rendered ineffective, or the required precautions against trespassers have not been provided;
- F. Any premises that is unsanitary, or that is littered with rubbish or garbage, or that has an uncontrolled growth of weeds; or
- G. Any structure that is in a state of dilapidation, deterioration or decay; faulty construction; overcrowded; open, vacant or abandoned; damaged by fire to the extent so as not to provide shelter; in danger of collapse or failure; and dangerous to anyone on or near the premises.

The bureau is also responsible for all origin and cause investigations of fires that occur in the Borough.

Since 1922, the week including October 9th has been designated as Fire Prevention week and recently in 2000 was extended to include the entire month. Fire Prevention Month has its roots dating back to The Great Chicago Fire of 1871 that killed 250 people and left over 100,000 homeless while destroying over 17,000 structures. This fire prompted the beginnings of fire safety. During Fire Prevention Month Fire Prevention Agencies join forces to educate the public on fire safety practices. Every year the Borough of Keyport Fire Prevention Bureau in conjunction with the Keyport Fire Department presents Fire Prevention Day at Keyport Central School. The Registrar of Vital Statistics maintains records of births, marriages and deaths that occurred in Keyport Borough.

Certified Copies

The fee for all certified copies in the Borough of Keyport is \$10.00 payable by cash, check or money order. Valid government issued identification is required. You must fully complete an application for a certified copy, and provide proof of your relationship to the individual named on the vital record you are requesting.

Marriage License Application

At least one member of the couple must live in Keyport Borough, New Jersey to apply for the marriage license here; unless both applicants are from out of State and are getting married in Keyport.

Appointments are **required** for marriage license applications. Please call 732-739-5136 to set up an appointment. Both members of the couple and one **(1)** witness over the age of 18 must attend the appointment. The witness cannot be the officiant performing the wedding ceremony. All three must have valid, government issued identification, and proof that one member of the couple lives in Keyport Borough.

If any of the three attending the application appointment do not speak and understand English you must bring an interpreter with you. The fee for the license is \$28 payable by cash, check or money order.

You must make application at least 72 hours before the wedding but we can accept applications up to 6 months prior to the wedding. Once the application is received by the Borough, there is a mandatory **72 hours waiting period** before the license can be issued. Please note that once the license is issued, it will only be valid for **30 days** after the date of issuance not the date of application.

After your ceremony, your officiant has the responsibility to file your license in the town where the marriage took place. Once the license is filed you **may** apply for a **certified marriage certificate** from the town where the ceremony occurred.

- **Licensing Your Dog:** All dogs seven months or older must be licensed.

Proof of Rabies Inoculation is required.

Rabies Vaccination Requirement: N.J.S.A. 4:19-15-3a requires that the duration of the immunity extends through out at least the first 10 months of the 12 month licensing period.

There is an additional charge for non-neutered or non-spayed animals (\$3.00 for dogs). Proof of Neutering/Spaying is required.

Dog licenses (\$8.20 for neutered \$11.20 for non-neutered) that are being renewed must be done by February 15th to not incur an additional \$15.00 late fee.

A Free Rabies Clinic will be held at the Public Works Building at 120 Francis Street please check website late summer for specific date.

The goal of this initiative will be to reduce the stigmas associated with mental illness and substance use disorder. We are dedicated to raising awareness of the diseases of mental illness and substance use disorders to create a culture where residents feel supported by their community and neighbors and feel free to seek treatment for the diseases without fear of stigma. Keyport Borough will be putting together a local committee to help foster programs and awareness campaigns throughout our Borough.

Keyport Borough is served by the Monmouth County Health Department.

They provide a number of Health and Environmental services, including:

HOUSEHOLD HAZARDOUS WASTE FACILITY: The facility is a safe and efficient system for the management and disposal of hazardous materials. Residents can drop off chemicals such as cleaners, pesticides, oil based paints, motor oil and much more.

AIR AND NOISE CONTROL PROGRAMS: This program routinely conducts site visits at gas stations and dry cleaners to determine compliance with NJDEP regulations. It also responds to citizen complaints of indoor air quality, radon, and odors. They also enforce regulations for bus and truck idling.

ADULT IMMUNIZATION CLINIC: Adult immunizations are available and include vaccines such as influenza, tetanus, pertussis and more. For further information call 732-431-7456, Ext 8513.

LEAD BASE PAINT ABATEMENT: Dwellings are inspected by a licensed Lead Risk Assessor with specialized equipment for children with elevated blood levels.

IMMUNIZATION CLINICS: The childhood immunization clinic provides immunizations to children from birth to 18 years old who do not have Insurance or who are underinsured. For an appointment call 732-431-7456, Ext. 8516

PUBLIC HEALTH NUISANCE COMPLAINTS: They investigate resident complaints about noxious weeds, solid waste, insects, rodents, etc. Call 732-431-7456, option 2.

MOSQUITO CONTROL DIVISION: Provides courtesy inspections of properties for standing water and controls mosquito larvae in this habitat as needed. Conducts community-wide pesticide applications for flying adult mosquitos.

RABIES CONTROL: Member municipalities are provided with free rabies vaccination programs for dogs and cats. Specific dates and locations can be obtained by calling 732-431-7456.

FOOD SURVEILLANCE AND SANITATION: Food establishments must operate in accordance with Chapter 24 of the NJ Sanitary Code. Food establishments are inspected at least once per year. Enforcement action can be taken as necessary to insure compliance.

INFECTIOUS DISEASE CONTROL: Health professionals and community members working together to coordinate efforts to heighten public awareness about disease prevention.
