Notice will be given of the time and place of a public hearing before the Mayor & Council and all interested parties by advertisement in two (2) newspapers of general circulation in the Borough, for two (2) successive weeks, at least one (1) in each week, and by posting such notice upon the lands or premises mentioned in the application...After such hearing the Mayor & Council shall by resolution grant or deny the application and approve or disapprove the plans and specifications filed therewith and, if approved, shall in its resolution, direct a license or permit to be issued. Said resolution shall be published in two newspapers of general circulation in the Borough for two (2) successive weeks, at least once in each, week, and by posting such notice upon lands or premises mentioned in the application.

**12-5.3** Every such license or permit or order granted or made for the construction, alteration, improvement or extension of any such wharf, pier, or other like structure, beyond low water mark of the waterway, or any harbor structure, shall become and be absolutely void, unless work thereunder shall be commenced within six (6) months after the date thereof and diligently prosecuted to completion.

**12-5.5-c** Every owner of such lands shall do and perform the work provided within sixty days of notice.
