

ORDINANCE #14-17

**OF THE BOROUGH OF KEYPORT, COUNTY OF
MONMOUTH, NEW JERSEY, AMENDING CHAPTER VII,
TRAFFIC TO REFLECT NEW PARKING RESTRICTIONS
AT FIRST STREET AND BROAD STREET**

WHEREAS, the Borough of Keyport (the “**Borough**”) is a public body corporate and politic of the State of New Jersey; and

WHEREAS, pursuant *N.J.S.A. 39:4-197*, the Mayor and Council of the Borough of Keyport (the “**Borough Council**”) have the power to adopt ordinances concerning traffic and parking within the Borough; and

WHEREAS, the Mayor and Borough Council hereby desire to amend Chapter VII, “Traffic,” of the Code to reflect new parking restrictions at First Street and Broad Street in the Borough, as follows (additions are underlined and deletions are in [brackets]):

**7-16 RESTRICTIONS FOR INGRESS AND EGRESS ONTO BROAD STREET FROM
BLOCK 80, LOT [1.01] 1.02.**

All vehicular traffic from the northern driveway on Block 80, Lot [1.01] 1.02 is hereby restricted and limited to ingress only from Broad Street and no vehicular traffic shall exit from the northern driveway on Block 80, Lot [1.01] 1.02 onto Broad Street within the Borough of Keyport.

SCHEDULE I - NO PARKING:

The following street location is added to SCHEDULE I

<i>Name of Street</i>	<i>Sides</i>	<i>Location</i>
<u>Broad Street</u>	<u>East</u>	<u>First Street South to the ingress only Driveway on Block 80, Lot 1.02</u>

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Keyport as follows:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. Chapter VII of the Borough Code shall be amended as follows:

**7-16 RESTRICTIONS FOR INGRESS AND EGRESS ONTO BROAD STREET FROM
BLOCK 80, LOT 1.02.**

All vehicular traffic from the northern driveway on Block 80, Lot 1.02 is hereby restricted and limited to ingress only from Broad Street and no vehicular traffic shall exit from the northern driveway on Block 80, Lot 1.02 onto Broad Street within the Borough of Keyport.

SCHEDULE I - NO PARKING:

The following street location is added to SCHEDULE I

<i>Name of Street</i>	<i>Sides</i>	<i>Location</i>
Broad Street	East	First Street South to the ingress only Driveway on Block 80, Lot 1.02

Section 3. All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed.

Section 4. Each section, subsection, sentence, clause and phrase of this ordinance is declared to be an independent section, subsection, sentence, clause and phrase and the finding or holding of any such portion of this ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this ordinance.

Section 5. The Borough Clerk is hereby directed, upon adoption of the ordinance after public hearing thereon, to publish notice of the passage thereof.

Section 6. This ordinance shall be in full force and effect from and after its adoption and publication as required by law.
