

ORDINANCE #15-16

ORDINANCE OF THE BOROUGH OF KEYPORT AMENDING CHAPTER XII OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH TO AUTHORIZE THE WAIVER OF PERMIT FEES FOR WORK DONE TO PROMOTE ACCESSIBILITY FOR DISABLED PERSONS.

WHEREAS, the Borough of Keyport, County of Monmouth (the “**Borough**”) is a public body corporate and politic of the State of New Jersey (the “**State**”); and

WHEREAS, the Chapter XII of the Revised General Ordinances of the Borough provide for building construction permit fees in the Borough; and

WHEREAS, pursuant to the Uniform Construction Code, N.J.S.A. 52:27D-126(e), municipalities are authorized to waive permit fees for construction, reconstruction, alteration or improvements designed and undertaken solely to promote accessibility by a disabled person to an existing public or private structure or any facilities contained therein; and

WHEREAS, in order to enhance the public interest of the Borough, and specifically to ensure the accessibility of disabled persons, the Mayor and Council desire to amend Section 12.1, having determined that it is in the public interest to revise the Ordinance.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Borough of Keyport as follows:

Section 1. The recitals are incorporated herein as if set forth in full.

Section 2. Borough Ordinance 12.1 shall be amended by inserting a new subsection 12.11 as follows:

12.11 Waiver of Fees for Work Done to Promote Accessibility for Disabled Persons. The Mayor and Council may, by adoption of a resolution, waive any and all fees under this Chapter XII for any construction, reconstruction, alteration or improvement designed and undertaken solely to promote accessibility by a disabled person to an existing public or private structure or any facilities contained therein in accordance with the terms and conditions of N.J.S.A. 52:27D-126(e).

Section 3. If any part of this Ordinance shall be deemed invalid such part shall be deemed severable and the invalidity thereof shall not affect the remaining part of this Ordinance.

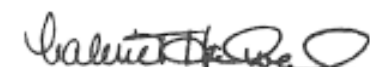
Section 4. All other terms and provisions of Chapter XII of the Revised General Ordinances of the Borough shall remain in full force and effect and any ordinance or portions thereof which are inconsistent with the provisions of this Ordinance are hereby repealed and superseded.

Section 5. This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.
