

ORDINANCE #2022-20

**ORDINANCE OF THE BOROUGH OF KEYPORT, COUNTY
OF MONMOUTH, NEW JERSEY, AMENDING CHAPTER 7
“TRAFFIC” AND CHAPTER 7A “TRAFFIC SCHEDULES”
OF THE REVISED GENERAL ORDINANCES OF THE
BOROUGH OF KEYPORT**

WHEREAS, the Borough of Keyport (the “**Borough**”) is a public body corporate and politic of the State of New Jersey; and

WHEREAS, pursuant *N.J.S.A. 39:4-197*, the Mayor and Council of the Borough of Keyport (the “**Borough Council**”) have the power to adopt ordinances concerning traffic and parking within the Borough; and

WHEREAS, the Mayor and Borough Council hereby desire to amend Chapter 7, “Traffic,” Section 14.2, and Chapter 7A, “Traffic Schedules,” Schedule I, to reflect revised traffic regulations.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Borough of Keyport, County of Monmouth, New Jersey that:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. Chapter 7, Section 14.2 entitled “Mid-block crossings schedule” is hereby amended as follows (additions are underlined):

§ 7-14.2 Mid-block crossings schedule.

The following mid-block crossings are located within the Borough:

Broad Street (County Route 4)	From a point 225 feet north of the northerly curblineline of Hurley Street to a point 10 feet north thereof												

Name of Street	Location
Broad Street (County Route 4)	From a point 430 feet south of the southerly curblin of East Front Street and West Front Street to a point 10 feet south thereof
Broad Street - Central School (County Route 4)	From a point 400 feet north of the northerly curblin of Jackson Street to a point 10 feet north thereof
Main Street	From a point 40 feet north of the northerly curblin of Hurley Street to a point 10 feet north thereof
Maple Place (County Route 516)	From a point 5 feet north of the northerly curblin of Orchard Street to a point 10 feet north thereof

Section 3. All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed.

Section 4. Each section, subsection, sentence, clause and phrase of this ordinance is declared to be an independent section, subsection, sentence, clause and phrase and the finding or holding of any such portion of this ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this ordinance.

Section 5. Except as amended by this ordinance, all other provision of the Borough's Revised General Ordinances shall remain in full force and effect.

Section 6. The Borough Clerk is hereby directed, upon adoption of the ordinance after public hearing thereon, to publish notice of the passage thereof.

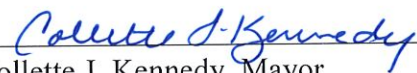
Section 7. This ordinance shall be in full force and effect from and after its adoption and any publication according to law.
