

ORDINANCE #25-16

ORDINANCE OF THE BOROUGH OF KEYPORT, COUNTY OF MONMOUTH, NEW JERSEY, AMENDING CHAPTER VII (TRAFFIC) OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF KEYPORT

WHEREAS, the Mayor and Council of the Borough of Keyport (the “**Borough**”) have reviewed and considered updates to the Revised General Ordinances of the Borough, pertaining to the traffic and parking in the Borough; and

WHEREAS, the Mayor and Council intend to amend Chapter VII (Traffic) of the Borough’s Revised General Ordinances to provide regulations pertaining to the traffic and parking in the Borough; and

WHEREAS, the Mayor and Council of the Borough have determined that the amendments to the Chapter VII of the Borough Code will improve the traffic flow and safety for pedestrians within the Borough.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Keyport as follows:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. The Mayor and Council of the Borough have determined to make the following amendments to the Chapter VII (Traffic) of the Borough’s Revised General Ordinances:

a. Chapter VII, Schedule I, entitled “No Parking” shall be amended by deleting the following first two lines appearing on the first page under the column headers:

<i>Name of Street</i>	<i>Sides</i>	<i>Location</i>
Atlantic Street	West	Union Street south to Highway No. 36
Atlantic Street	West	South from Jackson Street a distance of 50 feet

b. Chapter VII, Schedule IV, entitled “No Parking” shall be amended by deleting the first line appearing on the first page under the column headers and replacing that line as follows:

<i>Name of Street</i>	<i>Sides</i>	<i>Time Limit</i>	<i>Hours</i>	<i>Location</i>
ATLANTIC	West	15 Mins.	7:30AM to 3:30 PM	From UNION Street to MONROE Street

Section 3. All Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed.

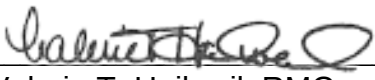
Section 4. Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

Section 5. Except as amended by this Ordinance, all other provision of Chapter VII (Traffic) of the Borough's Revised General Ordinances shall remain in full force and effect.

Section 6. The Borough Clerk is hereby directed, upon adoption of the Ordinance after public hearing thereon, to publish notice of the passage thereof.

Section 7. This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.
